1) DEFINITIONS:

- 1) Association means the "ALUMNI ASSOCIATION OF DR. H.N. SINHA ARTS & COMMERCE COLLEGE, PATUR, DIST. AKOLA".
- 2) Executive President means the Executive President of the "ALUMNI ASSOCIATION OF DR. H.N. SINHA ARTS & COMMERCE COLLEGE, PATUR, DIST. AKOLA".
- 3) President means the President of the "ALUMNI ASSOCIATION OF DR. H.N. SINHA ARTS & COMMERCE COLLEGE, PATUR, DIST. AKOLA".
- 4) Vice- President means the Vice- President of the "ALUMNI ASSOCIATION OF DR. H.N. SINHA ARTS & COMMERCE COLLEGE, PATUR, DIST. AKOLA".
4.1) Vice President - 2 means the Vice President - 2 of the "ALUMNI ASSOCIATION OF DR. H.N. SINHA ARTS & COMMERCE COLLEGE, PATUR, DIST. AKOLA".
- 5) Secretary means the Secretary of the "ALUMNI ASSOCIATION OF DR. H.N. SINHA ARTS & COMMERCE COLLEGE, PATUR, DIST. AKOLA".
- 6) Treasurer means the Treasurer of the "ALUMNI ASSOCIATION OF DR. H.N. SINHA ARTS & COMMERCE COLLEGE, PATUR, DIST. AKOLA".
- 7) Joint Secretary means the Joint Secretary of the "ALUMNI ASSOCIATION OF DR. H.N. SINHA ARTS & COMMERCE COLLEGE, PATUR, DIST. AKOLA".
- 8) Member of Managing Committee means the member of managing committee of "ALUMNI ASSOCIATION OF DR. H.N. SINHA ARTS & COMMERCE COLLEGE, PATUR, DIST. AKOLA".
- 9) The Principal and Coordinator of "DR. H.N. SINHA ARTS & COMMERCE COLLEGE, PATUR, DIST. AKOLA" shall be the Ex-officio member of Managing Committee of "ALUMNI ASSOCIATION OF DR. H.N. SINHA ARTS & COMMERCE COLLEGE, PATUR, DIST. AKOLA".
- 10) Other Member means the member of the "ALUMNI ASSOCIATION OF DR. H.N. SINHA ARTS & COMMERCE COLLEGE, PATUR, DIST. AKOLA".



- 2) **JURISDICTION:** - The jurisdiction of society shall be throughout Maharashtra.
- 3) **ACCOUNTING:** - Accounting year will be from 1st April to 31st March every year.
- 4) **MEMBERSHIP & ITS ENROLLMENT:** - A person having the age of more than 18 year and who is the ex-student of "DR. H.N. SINHA ARTS & COMMERCE COLLEGE, PATUR, DIST. AKOLA" can be member of the association. Those who want to become a

member, and he/she has to make an application in prescribed format to the Managing Committee through Secretary. After acceptance of membership fee will be deposited, the Managing Committee shall have the right to reject membership form without assigning any reason.

5) CATEGORIES OF MEMBERSHIP: -

1) Life member: - All founder members shall be the life members. One who contributes Rs. 100/- in one time shall be the life member of the association. His / Her tenure will be for the whole life.

6) RULES REGARDING DISMEMBERSHIP: - The managing committee shall be passed resolution by 2/3 majority in its meeting for dismembering a member for the following reason.

I) If he/she remains absent 3 meeting consecutively without intimation.

II) If his/her behavior proves to be harmful in the interest of the association.

III) If his/ her behavior appears against the rules of the association.

IV) If he is found to be of unsound mind, bankrupt and imprisoned or involve in antisocial activity.

7) POWERS & DUTIES OF GENERAL COUNCIL: - General Council shall be the Supreme Body. All members can participate in the General Council meeting. It shall be held at least once in a year. To take final decision, to pass the budget and audit reports produced before the meeting, to prepare new programmes in the interest of the association, if needed to form sub-committees to amend the constitution Managing Committee.
